PUBLIC OPINION STRATEGIES POLLS IN 13 SUCCESSFUL MAJOR STATEWIDE RACES; HELPS ELECT SEVEN NEW MEMBERS OF CONGRESS (SO FAR)

The survey research firm of Public Opinion Strategies (POS) polled on behalf of winning candidates in 13 of the key statewide races this year, at least seven new Members of Congress, and as well at least 25 Members of the impending GOP House majority.

Major statewide winners were:

- Re-elected Governor Greg Abbott of Texas, winning the most expensive gubernatorial race in the state's history.
- Re-elected Governor Phil Scott of Vermont, winning a state Joe Biden carried with 66% of the vote.
- Re-elected Governor Kim Reynolds of Iowa, the first woman to be re-elected as Iowa's Governor.
- Re-elected Senator Todd Young of Indiana.
- Re-elected Senator Mike Crapo of Idaho.
- Worked on behalf of the Republican Governors Association to re-elect Governor DeWine of Ohio, Governor Sununu of New Hampshire, Governor Stitt of Oklahoma, and Governor Dunleavy of Alaska.
- Assisted the Republican Governors Association in flipping Nevada's Gubernatorial Mansion (Joe Lombardo is leading at press time).
- Worked with Senate Leadership Fund to aid Senator Marco Rubio in his decisive win in the Florida Senate race.
- Helped Senate Leadership Fund propel J.D. Vance to a come from behind victory in the Ohio Senate race.
- Re-elected Justice Pat DeWine to the Ohio Supreme Court, extending Republicans 36year streak of holding a majority on the court.

In addition to our statewide work, Public Opinion Strategies currently has helped elect seven new Members of Congress, four being a flip in control. Along with the 25 Members of Congress who have already won, the firm also has 23 clients for Congress in races that have yet to be called, including 13 that would be flips.

Public Opinion Strategies also polled for successful House Independent Expenditure campaigns in three races, as well as IE polling for eleven additional races that have not been called.

The firm also polled for winning legislative campaigns in five states: California, Illinois, Missouri, Ohio, and Kentucky. Our work helped maintain a majority in the Missouri State House and supermajorities in the Ohio State House as well as the Kentucky State Senate and State House.

The firm also conducted the opinion research which guided successful ballot issues in two states. In Arkansas the firm lead the research effort in opposition to recreational marijuana. California Proposition 29 to further regulate dialysis clinics was defeated with over a 70% No vote, a new high-water mark for a proposition that was appearing on the ballot for the third time.
